1 Respective responsibilities of the auditor and the authority

Our responsibility as auditors to complete a **limited assurance review** is set out by the National Audit Office (NAO). A limited assurance review is **not** a **full statutory audit**, it does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and hence it **does not** provide the same level of assurance that such an audit would. The UK Government has determined that a lower level of assurance than that provided by a full statutory audit is appropriate for those local public bodies with the lowest levels of spending.

Under a limited assurance review, the auditor is responsible for reviewing Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with NAO Auditor Guidance Note 02 (AGN 02) as issued by the NAO on behalf of the Comptroller and Auditor General. AGN 02 is available from the NAO website — https://www.nao.org.uk/code-audit-practice/guidance-and-information-for-auditors/ .

This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with *Proper Practices* which:

- summarises the accounting records for the year ended 31 March 2023; and
- · confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

2 External auditor's limited assurance opinion 2022/23

Other matters not affecting our opinion which we draw to the attention of the authority:

Except for the matters reported below on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return, in our opinion the information in Sections 1 and 2 of the Annual Governance and Accountability Return is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

In undertaking the review of the 2022/23 Annual Governance and Accountability Return it came to our attention that in 2023 the Council included trust fund transactions in their accounting statements in Section 2 of the Annual Return. These should have been excluded from the figures in Section 2. In 2023/24 the Council should ensure that the Annual Governance and Accountability Return is prepared in accordance with proper practices.

The Accounts and Audit Regulations require that the Authority retains copies of the Annual Governance and Accountability Return readily accessible for 5 years (Paragraph 13.2). This requirement has not been met; however, the Council answered "yes" to Assertions 3 and 4 in Section 1 regarding compliance with laws and regulations in general and specifically observing the elector's rights contained in the Accounts and Audit Regulations. In 2023/24 the Council needs to put in place arrangements to ensure that it fully complies with the Accounts and Audit Regulations.

The Council asserted in its Annual Governance Statement that during 2022/23 it provided proper opportunity for the exercise of public rights, but it did not publish the completion notice at the conclusion of the 2021/22 audit on a free to access website in accordance with the Accounts and Audit Regulations (2015). In 2023/24 the Council needs to put in place arrangements to ensure that it fully complies with the Accounts and Audit Regulations.

The Council has not fully implemented recommendations made in 2021/22 internal and / or external audit reports. The Council answered yes to the relevant assertion in the 2022/23 Annual Governance Statement (assertion 7), claiming it has taken appropriate action in respect of audit reports, instead ticking 'No' to Assertion 6, which was irrelevant. In future, the Council should ensure that appropriate action in response to audit recommendations is taken within a reasonable time frame.
